

SUMMARY ANNUAL REPORT FOR PEPSI-COLA BOTTLING CO. OF CORBIN KENTUCKY, INC. EMPLOYEE BENEFITS PLAN

This is a summary of the annual report of the PEPSI-COLA BOTTLING CO. OF CORBIN KENTUCKY, INC. EMPLOYEE BENEFITS PLAN, a health, life insurance, dental, vision, temporary disability and long-term disability plan (Employer Identification Number 61-0601744, Plan Number 501), for the plan year 01/01/2017 through 12/31/2017. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

PEPSI-COLA BOTTLING CO. OF CORBIN KENTUCKY, INC. has committed itself to pay certain Dental claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with HUMANA HEALTH PLAN, INC., METROPOLITAN LIFE INSURANCE COMPANY, KANAWHA INSURANCE COMPANY, UNUM LIFE INSURANCE COMPANY OF AMERICA, THE DENTAL CONCERN, INC and DENTAL OF KENTUCKY to pay certain Health, Vision, Life insurance, Temporary disability, Long-term disability, and other claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2017 were \$2,283,569.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2017, the premiums paid under such "experience-rated" contracts were \$101,839 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$93,163.
